

The main problem here, aside from the obvious weight difference, is that trucks tend to be much taller with higher ground clearance, resulting in smaller vehicles becoming underpinned in accidents. Another factor is braking capability. A fully loaded tractor trailer can take up to 40% longer to stop than cars. This is compounded when slippery road conditions are taken into consideration.
