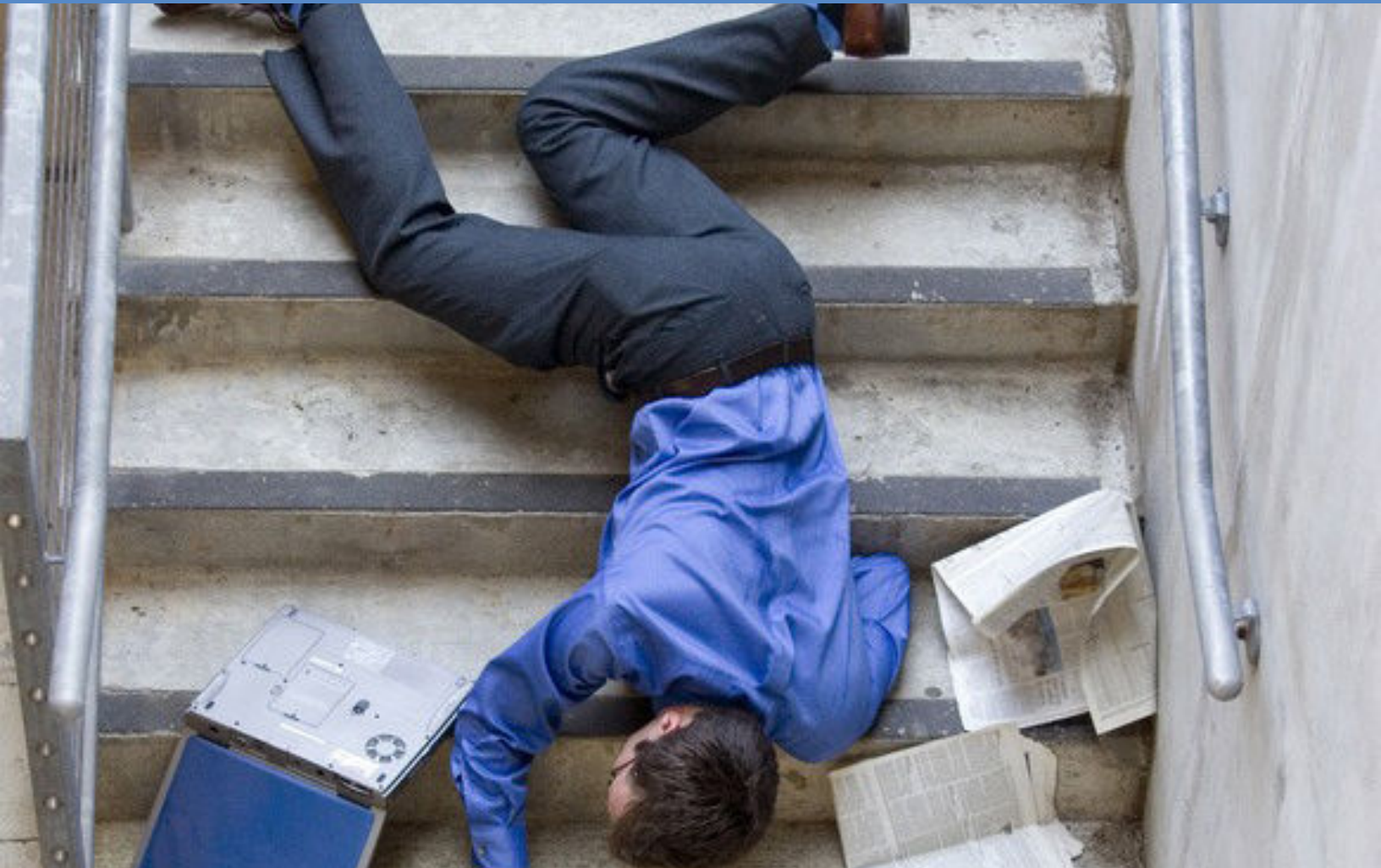

# 4 QUALITIES

of a Good Lawyer for

# Slip and Fall Claims



Getting seriously hurt while on someone else's property is bad enough – but when the accident could have been prevented, the loss is compounded. From hip fractures and shoulder injuries to TBIs and sprains, slip and fall cases are some of the most common we see. Property owners have a duty to the public to warn them of any dangers present. In addition, they are responsible for making sure the property is safe for customers and employees. This includes patching crumbling steps, repairing uneven surfaces and cracks in sidewalks, installing hand rails on stairs and cleaning up spills immediately.

This is known as “premises liability” and it refers to property owners' responsibility to ensure safe conditions for visitors, employees and residents. Under California law, property owners can be held financially liable for slip and fall accidents that happen on their property. Unfortunately, these types of accidents are all too common.

The statistics aren't pretty. According to the [CDC](#):

- ✓ 1 in 5 falls results in a serious injury like a broken bone or a head injury.
- ✓ Nearly three million older adults get treatment in ERs for falls every year.
- ✓ More than 800,000 people a year go to the hospital due to a fall, such as head injury or hip fracture.
- ✓ Three hundred thousand people go to the hospital with hip fractures each year.
- ✓ Falls are the top result of traumatic brain injuries (TBIs).

## What to Look For

If you have suffered an injury that could have been prevented had the owner of the property properly maintained the area, you need the services of a qualified slip and fall attorney in Lancaster. This can be a daunting prospect to many who may not know where to begin. Here are some qualities you should be on the lookout for in an attorney:

# 1 Qualifications

Just like you wouldn't see a medical specialist without researching his or her background, you shouldn't hire a personal injury lawyer without doing your homework. When researching Lancaster slip and fall attorneys, make sure they can handle all elements of your lawsuit, including anything related to depositions, motions, arbitrations, mediations and trial if necessary. Make sure they have specific experience with your type of case and ask what the timeline to expect may be. Your lawyer should be able to give a high-level overview of the process involved, let you know how often they'll be checking in, etc. Look into their academic and other accreditation background to ensure they are indeed qualified to work on personal injury cases.

# 2 Accessibility

Any lawyer you have to call repeatedly just to get a question answered or to follow up on an issue isn't worth your time. A personal injury claim is stressful to say the least. Facing unanswered phone calls compounds this stress for you. Make sure your slip and fall attorney in Lancaster is accessible at all times, not just when you have to attend scheduled settlement or court sessions. This open form of communication is especially important in a slip and fall case because you may be hospital- or home-bound due to your injury and can't travel to and from the law office.
