# **Specialty**

Most PI lawyers handle a large volume of car accident cases, as they are the most common. But it still doesn't hurt to ask about their track record: how many similar cases they have handled, what their settlement and verdict rate is, etc.

#### **Focus**

Focus areas to ask about include experience, location (have they been serving the same service area for a number of years?), skill level, reputation, commitment to clients and fee structure. When interviewing Los Angeles car accident lawyers, make sure they are well-informed in California transportation laws and that they effectively know how to handle the insurance and healthcare companies. Because car accidents are so common in LA, everyone here is aggressive, from the drivers to the lawyers and yes, to the insurance companies. You need someone who won't fall for the insurance companies' tricks.

Your lawyer should be properly prepared to settle a car accident case but you also want one who isn't afraid to take the case to court if need be. Most lawyers accept cases on a contingency basis, which means they don't get paid until you win or settle. Make sure this is the case with any lawyer you go with.

#### **Details**

Car accident lawyers should have vast resources to explore every inch of your case, including details about the accident itself, the extent of your injuries and financial losses. They should be willing to hire accident reconstruction experts and be willing to meet with your doctors and specialists to fairly estimate what your future medical expenses will be.
