Details

Navigating a wrongful death case on your own is not always advisable. You're in the middle of grieving the loss of your loved one, which can cloud judgement and make any part of the process murky. Ask yourself: are you thinking clearly enough to research all of the relevant statutory laws? What about federal laws that may be involved? Are you aware of all the filing dates? Can you meet each discovery request? Each state has different requirements for wrongful death cases, so you may also be contending with probate claims in order to disburse the decedent's estate to all legal heirs.

Because wrongful death cases rely heavily on evidence, you want to choose an attorney who can investigate the circumstances fully and secure vital evidence. It's not uncommon for negligent parties to attempt to escape responsibility by refusing to acknowledge their role in the tragedy. Once they see a tough litigator get involved, they know the problem isn't just going to go away. Often, this will encourage the responsible parties to settle. When the defendants still display resistance, you want a lawyer who will push even further to prove their liability at trial.

Experience and Resources

Not all personal injury lawyers specialize in wrongful death cases. This area of the law is complex, often dragging out over the long term due to the many factors, witnesses, and possible responsible parties involved. These cases take a lot of resources to pull off, from accident reconstruction to assessing liability, which can be very complicated if there are many parties involved, as in the case of a product malfunction, for example. But even within wrongful death, there are subsets. For instance, if your loved one was killed in a construction accident, make sure the lawyer you hire has handled those types of cases before. Those are very different than medical malpractice cases.

Background

Don't discount online and personal reviews; however, don't stop your research there. Look into the lawyer's background and experience, and check if there have been any disciplinary actions against that particular attorney. One good resource to check is the [State Bar of California](#).
