California led the country during the first half of 2017 with more than 350 pedestrian fatalities. Los Angeles County was also #1 in pedestrian deaths in 2016 with 265. The reasons for these accidents vary. There are far more people walking to work, not to mention more vehicles on the roadways and more people being distracted by smart phones, to name a few.
