Have a plan of what you're going to ask during your free consultation.

Question #1: What is your background and experience?

This is the best way to get a good feel for who your lawyer is as a person, along with whether or not they're qualified to help you. Consider asking a combination of these questions:

- ✓ Where did you go to school?
- ✓ Do you belong to a professional organization?
- ✓ How long have you been practicing law in the LA area?
- ✓ Do you specialize in personal injury law?
- ✓ Do you represent many accident victims? What makes up the bulk of your practice?
- ✓ Have you defended cases like mine before? If so, how many?

Question #2: How do you assess my particular case?

Be sure to bring your case history with you to the meeting. This should include everything from the accident report to your medical records to bills you have received from that medical care. You'll also need insurance letters and photos of your injuries and the accident scene. Share this paperwork with the attorney and explain the events. Ask these questions:

- ✓ What works in our favor? Against us?
- ✓ Do you think this case could go to trial?

You shouldn't have to pay for the poor choices someone else made.

- ✓ What kind of financial compensation can I expect to receive?
- ✓ Is mediation or arbitration possible?
- ✓ What's the anticipated timeline?

Question #3: How will you manage my case?

Every firm manages their cases in a different way. Some have a whole team dedicated to a variety of cases. Others have one lawyer who handles the case from start to finish. Know who your point of contact will be so you can always get in touch with them going forward.

- ✓ Will you handle my case or pass it to another attorney within the practice?

- ✓ What is the best way to contact you?

Question #4: Can you provide me with an estimate of my costs?
